Correspondence – by Supervisor Brooks

- ➤ Received email from Mark Boncek, Chairman of the Town of Denning Zoning Board of Appeals seeking Town Board approval to hold an Organizational and Training meeting of the ZBA on Thursday, September 29, 2022 at 6 pm at the Denning Town Hall in Claryville, NY. Supervisor Brooks requests a Motion to approve such request. Motion made by Gregory Vurckio and Seconded by Paul Schoonmaker. Motion carried following a unanimous roll call vote.
- ➤ Checks and correspondence received from Ulster County for 4/22 through 6/22 sales tax revenue for Denning, and additional 1% payment of 2021 sales tax revenue for all of last year.

Highway Report: Highway Superintendent Van Saders reports:

- ➤ Two pipes have been changed on Peekamoose Road and paved over. Paving has also taken place on New Road Hill, Wildcat, Taylor, and portions of Round Pond Road by the swamp and on the hill; and Whitehouse Road as well in Sundown.
- ➤ Highway Superintendent Van Saders wishes to thank Preston Kelly and the Neversink Highway Department for all their hard work and help with the Denning paving this year.
- > It is noted that the Deputy Superintendent's 2004 truck had a head gasket issue and was sent for service.
- > The 2002 International has a broken back brake rod. Hopefully this will be a quick repair.
- ➤ The 550 was back but is now out again MAF sensor issue. Highway Superintendent Van Saders does not have high hopes for the vehicle for the winter. Discussion follows regarding issues with this vehicle and possible solutions.
- ➤ There are ongoing issues with the cameras at the Highway Garage and the R&R Facility. IT, Eben Ackerley, will be contacted.
- Councilman Vurckio asks approximately how many miles of Town of Denning Road were paved this year. Highway Superintendent Van Saders reports it is at least 5 miles, possibly a bit more. Next year they will tackle the remaining two plus miles on Peekamoose Road. Dymond Road is CHIPS eligible next year also. If Ulster County is willing to help with Peekamoose and Dymond Road paving maybe Neversink could help with the tar and chipping.
- ➤ Councilman Dean asks if there are any Dead-End signs for Taylor Road. Highway Superintendent Van Saders will check.

➤ Councilman Smith reports that he was unable to attend last months' Planning Board meeting. He did follow up with Chairman Sibiga who reported there was no new or old business to discuss. Planning Board members reviewed the previous months' minutes and closed the meeting.

- ➤ Blue Hole is status quo we are now past peak season.
- Titan Drilling stopped at the Town Hall and Highway Garage and took water samples last week according to Highway Superintendent Dan Van Saders. Water is still discolored at the Town Hall. Slight sulphur smell at the Town Barn where the filters have been clean, water is clear and everything has been running well. Waiting to hear about Town Hall water sample.
- > Supervisor Brooks requests that Highway Superintendent Van Saders check on schedule for servicing the two Town generators. Can they be done at the same time?
- ➤ There are 13 issues regarding the Claryville Denning Septic District to be taken care of. Supervisor Brooks is in discussion with Jim Sheeley about getting the work done.

Supervisor Brooks calls for Councilmen Comments:

- ➤ Councilman Vurckio asks Highway Superintendent Van Saders about washing the trucks and equipment without having the doors open due to the high cost of heating fuel for the coming winter months. Discussion follows regarding the pressure washer it is exhausted out the top. It is suggested that they problem-solve for a chimney or adaptation kit. All door seals should be checked and serviced for leaks.
- > Councilman Vurckio reports there was no CWT meeting the previous month.
- Councilman Schoonmaker was not available for Court this month.
- Councilman Dean has no comments.
- Councilman Smith has no comments.
