## Supervisor Comments:

- > Supervisor Brooks advises the Board that he met on-site with the CWC after relieving the former engineering firm of their duties for the Sundown Stream Project as reported at last month's Town Board meeting. At this time going ahead with an application for a feasibility study to armor Peekamoose Road and below the new bridge. Supervisor Brooks is hopeful this project can still be completed.
- > Supervisor Brooks advises the Board that the NYS DEC Blue Hole Project has progressed and the hiking trail has been marked out from the parking area Crossing Peekamoose Road and utilizing the old bridge to Blue Hole. abutments. The walkway will run alongside the road. There will be added traffic when that project begins. Hopefully it won't affect the Denning paving project.
- Supervisor Brooks advises the Board that NY State and Ulster County recently passed a law regarding Firefighter tax exemptions and explained that it is up to each municipality individually to offer the exemptions. Supervisor Brooks explains that Denning will be a "No" for 2023 until more information can be reviewed and researched. The only Ulster County Town who has moved on this matter is New Paltz. Every other town has backed off and is looking for more information. Supervisor Brooks reports that after

the Ulster County Hazard Mitigation Kick-off meeting a brief discussion was held for those in attendance. Supervisor Brooks reports that all information needs to be closely reviewed before Denning acts on this matter. Discussion follows.

Supervisor Brooks calls for Councilmen Comments:

- Councilman Vurckio informs the Board regarding the CWT meeting on January 16<sup>th</sup>. Topics covered included:
  - 2022 Revised Filtration Avoidance Determination (FAD) from the NYS Department of Health updated from 2017.
    - NYC DEP Land Acquisition Program (LAP)
    - NYC DEP Streamside Acquisition Program (SAP)
    - Conservation easement granted by DEP to DEC for utility access and renewable energies.
    - License agreements with annual payments to landowners as an alternative to fees.
    - DEP working with CWC regarding future septage disposal needs in the watershed.
    - DEP's obligation to meet regularly with stakeholders to resolve issues with administration of city contracts.
  - Since the CWT's concerns were addressed in the revised FAD a resolution was passed by the CWT on January 16<sup>th</sup>, 2023 to support NYS Dept. of Health revised FAD.
  - o There will be no meeting in February.
  - o April 4, 2023 is the CWC Annual Meeting.
- Councilman Schoonmaker informs the Board that Justice Court was cancelled on February 8<sup>th</sup> and advises the next Court date is February 22<sup>nd</sup>.
- > Councilman Dean has no comments.
- > Councilman Smith has no comments.
