#### **Old Business:**

 A Resolution was accepted to rollover the \$93,000. 00 from the CD and add to it \$125,000.00 out of Capital Reserves into a new CDARS CD Account for 12 months at 4.20%. The account will be called "Capital Reserves".

This will leave \$66,000.00 in the Capital Reserves Budget.

- Hose testing schedule is calculated for a 3-year cycle this will be discussed in 2024
  Budget for a 2-year cycle.
- Glenn will schedule the same person to do physicals.
- Department needs an up-to-date inventory of repair items that are ordered each year. Paul will look into the records management.

### **New Business:**

- Dave Bodenstein from Mike Price Inc. insurance agency went over the 2023 insurance policy for the District. Changes were made to the amount of coverage on the trucks and trailer, Upon Motion by Terry, Seconded by Tom, None Opposed.
- VFBL coverage was discussed.
- Ulster County self-insurance will attend the March District meeting.
- Quote for the Drager multi-meter which detects 4 different kinds of gas is \$1,200.00 with a vehicle charger kit for truck 6561. Also discussed was the purchase of 3 small CO2 meters. These expenditures approved Upon Motion by Terry, Seconded by Mike. None Opposed.

- A new blue/white light bar needs to be purchased; approved Upon Motion by Terry, Seconded by Tom. None Opposed.
- Discussion of other capital expenditures tabled until full Board is present.
- A Resolution to adopt the *Retention and Disposition Schedule for New York Local Government Records (LGS-1)* was approved Upon Motion by Terry, Seconded by Tom. None Opposed. Copies of the Resolution will be given to Commissioners.
