- ➤ Invitation from Frost Valley YMCA to meet Riel Peerboom, the new CEO, on Sunday June 11, 2023.
- ➤ Donation check received from the Frost Valley YMCA in the amount of \$10,414.00. The Denning Town Board expresses its ongoing thanks to the Frost Valley YMCA Board for their continued support.
- ➤ Letter from the Ulster County Board of Elections notifying the Town that there is no primary voting in Denning on June 27, 2023.
- ➤ Email received from Patricia Masterson, Town of Denning Assessor, advising that the assessment for NYS owned properties in Denning has been increased and will take effect July 1, 2023. Discussion follows. The Board wishes to express their gratitude to Ms. Masterson for all her hard work regarding this matter.
- > Supervisor Brooks advises the Board that he is in talks with the Ulster County Dept. of Finance Interim Commissioner, Ken Juras, regarding payments made by NYS to Ulster County for State owned parcels in Denning. Supervisor Brooks is requesting that the monies due the Town be turned over by the County as soon as the payments are received by the County instead of waiting until July to pay those monies owed to the Town. Discussion follows.

Highway Report: by Highway Superintendent Van Saders:

- ➤ Winter Season is done and the trucks are all turned over.
- > 2002 International oil leak and cam shaft repair.
- > Working on York-raking Denning Road, Wild Meadow Road, Taylor Road and Barnes Road.
- Ditch digging up on Red Hill Knolls Road and the Town is seeding the ditches after cleaning.
- > The motor was replaced on the Recycling Center overhead door.
- ➤ Used the Ford 550 to get compost from Frost Valley for use in the Jean Switzler Memorial Garden.

- > Supervisor Brooks asks for an update on the purchase of a Buffalo Turbine. Superintendent Van Saders states he got no response from Keil and is looking into it further.
- Councilman Mike Dean filled in at the transfer station on Sunday as Rich Lowe was unavailable. Mr. Dean requested an updated key for the Town Barn and Recycling Center. Superintendent Van Saders will get him one. Mr. Lowe is scheduled to be back for Wednesday.

The first phase of the parking and camping changes and new trail to the Blue Hole area will be started about the 2nd week in June. DEC advises that they will not close the road. Supervisor Brooks requested a smaller number of permits be issued to control the number of visitors this season. Supervisor Brooks advised the DEC that Denning will be paving parts of the road this summer.
- > Waiting for contracts from SLR Engineers regarding the Sundown Stream Project.
- ➤ It has been determined that Rich Lowe will be pressure washing and staining the Highway Garage. Discussion follows regarding timing of the work and whether it should be a natural color stain and sealer. Supervisor Brooks will discuss specifics with Mr. Lowe and Highway Superintendent Dan Van Saders.

Supervisor Brooks calls for Councilmen Comments:

- ➤ Gregory Vurckio reports that there was no CWT meeting last month. The next meeting is next week. Still negotiating with NYC DEP.
- ▶ Paul Schoonmaker reports on the Justice Court. Judge Follender wants Denning to advocate for public transit bus service. Supervisor Brooks will contact Ulster County regarding same. One DWI matter before the Court on April 12th.
- ➤ Mike Dean reports that resident Paul Tison reached out to thank and commend the Highway Department on their good work with the road maintenance this Spring after a rough winter on the roads. Highway Superintendent Dan Van Saders stated that Mr. Tison did call him directly.
- Kevin Smith has no further comments.
