Forestry Grant: Reviewed Grant. Tom wants to purchase a bare body in order to fabricate a brush fire vehicle. Tom has requested authorization for expenditure of \$1, 974.79 which will need to come out of the Budget. Approved Upon Motion by Dave, Seconded by Mike, None Opposed.

Resident requested a controlled burn of an old barn. Because of numerous considerations, the request was denied Upon Motion by Andy, Seconded by Dave. None Opposed. Dave will talk to resident and explain.

Chief Glen VanDenBerg would rather have a light bar for his truck than the traditional white helmet upon his retirement as Chief. A motion was made by Dave to approve this request, Seconded by Mike. None Opposed.

Paul will review Standard Operating Procedures and bring them up to date.

Homeowners on Red Hill who have property where there is drafting available for fire trucks Hve been identified, and addresses will be given to Secretary for letters to be sent.

A resolution was passed to authorize \$7,000.00 from Equipment Reserves for a water tank trailer to assist in brush fire fighting, subject to a permissive referendum. Upon Motion by Dave, Seconded by Mike. None Opposed.
