#### **Old Business:**

Consolidation: Objective is to save taxpayer money,

Problem with Frost Valley truck #11- There are a lot of mice in the FV substation. Need to send a letter to FV to repair the truck house and get rid of the mice. Dave will craft a letter to FV.

Prestige Towing - plaque created by Tom, and a letter has been written by Paul to show appreciation for towing services.

AED Grant – no news, but contract has been signed and is in progress.

**New Business**: - Budget is 10% over cap in anticipation of increased costs due to new OSHA regulations going into effect.

Building costs will be voted on at the September Meeting.

Ballot Clerks receive compensation of \$70.00.

Zoom Meeting with Greg and Alyssa from the D'Amato Law group about the procedure to create Capital Reserve Funds.

Internal designation of funds must follow a certain process. Accumulating a lot of money requires a capital plan.

Each fund is dedicated to a specific purpose.

Capital Reserve Funds can only be established by a Mandatory Referendum pursuant to General Municipal Law. This requires a special election to create these accounts.

After the Budget Hearing money cannot be added to a reserve fund.

Spending money from the reserve funds requires a permissive referendum

Tom made the Resolution to create Capital Reserve Funds, Andy seconded. None Opposed. These funds will be voted upon by the public at a special election on September 17, 2024.
