Committee Report: Tom, Paul, and Mike S. attended the Sullivan County Fire Commissioners Meeting. Dave Dennison announced that the Sate will no longer cover non-Fire District vehicles that go to a call that is out of District. One suggestion is to purchase a used truck to carry a 5-person crew to a call. The truck could also be used to transport members for training purposes. It would necessitate an additional bay on the Fire House. The Company will apply for a grant to add another bay anyway to use for equipment storage. The Commissioners will re-visit the issue at future Meetings.

Old Business: Tom presented a revised quote for a camera security system for the truck house: 4 cameras for \$4,550.00. Tom made the motion to approve installation of the system in 2026, Seconded by Andy, None opposed.

The contractor for the substation at Frost Valley (Company is paying for this) will work from the inside out.

Records Retention Policy Draft due from Anne-Marie.

Seven copies of the policy book will be ordered from Liberty Press.

New Business:

- Trucks need new plates need to apply for certificates of ownership for some vehicles, unless they can be found in the files.
- Lights on 61 figured out how not to stall the generator.
- Hudson Valley Bank Collateralization: Paul, Mike S. and Andy K. named as contacts.
- Credit card for District may be available from HVCU in 2026.

Resolution:

December 2, 2025: The following change to 2025 appropriations is hereby approved by the Board of Fire Commissioners:
